Toyo Tires Implements Organizational Reform

Osaka, Japan – 10 February, 2012 – TOYO TIRE & RUBBER CO., LTD. (President and CEO: Kenji Nakakura), announced the following organizational reform and management changes, effective April 1, 2012.

1. Organizational Changes

- Planning Division is renamed "Corporate Planning Division".
- Tire Planning Department (part of the Planning Division) is eliminated.
- DT Planning Department (part of the Planning Division) is moved to DT Business Group Headquarters.
- The following three sales divisions are eliminated: Toyo Tire Overseas Sales Division; Toyo Tire Domestic Replacement Sales Division, Nitto Tire Sales Division. The following four departments are eliminated: Toyo Tire Overseas Sales Department No.1; Toyo Tire Overseas Sales Department No.2; Tire Sales Administration Department; SCM Department.
- "Tire Planning Division" is newly created within Tire Business Group Headquarters.
- "Tire Strategic Planning Department" and "Tire Business Unit Administration Department" are newly created within the Tire Planning Division.
- China/Asia Business Promotions & Coordination Office is merged into the Tire Strategic Planning Department.
- Tire Manufacturing Division is renamed "Tire Production Management Division".
- The global tire business is divided into the following seven new Business Units: Japan, North America, China, Asia & Oceania, Europe, Independent Distributors and Nitto. They become part of the Tire Business Group Headquarters.
- "Tire Logistic Department" is newly created within "Tire Business Group Headquarters".

2. Purpose and Goal of the Reorganization

- These organizational changes are being implemented to quickly and effectively achieve the global growth goals set forth in the company's "Mid-Term Business Plan '11".
- The planning function for each of the tire and non-tire businesses will be placed under the direct command of each Business Group Headquarters so as to enhance and accelerate their planning capabilities.
- The Tokyo office is being closed and their functions consolidated with the Osaka headquarters office. The goal is to eliminate duplication and diffusion of resources, especially as it relates to the tire business, so that the planning, management and supply chain functions can become more efficient and effective.
- The objectives behind establishing and vesting clear authority and responsibility in each of
 the seven new Business Units is to enable more timely decision-making, and to ensure that
 planning and implementation of strategy can be devised to suit local market conditions with
 greater speed and effect.
