- 6. Organizational Changes (effective July 1, 2015)
 - 1) Seismic Isolation Rubber Division, which was established urgently for seismic isolation rubber problems, is duly organized.
 - 2) Technology Management Center is dissolved. Some quality assurance departments are upgraded to Quality Assurance Division, and it affiliates Tire Quality Assurance Dept. and DT Quality Assurance Dept. In addition, Standards Management Dept., which specializes in evaluating and controlling application for certification, is newly established under Quality Assurance Division.
 - 3) Fundamental Technology Center is newly established, and Central Research Center, Production Engineering Center and Environment, Safety & Health Enhancement Dept. are transferred to it.
 - 4) Intellectual Property Dept. is transferred to Central Research Center.
 - 5) CSR Center is renamed Compliance & Legal Center.
 - 6) CSR Promotion Dept. is renamed Compliance Promotion Dept. It has charge of secretariat of the Compliance Committee, putting instructions of Chief Compliance Officer (COO) into practice, planning and carrying out company-wide measures, coping with and supporting compliance matters in cooperation with Compliance Officers and related departments, supporting member of Compliance Committee, and so on.
 - 7) CSR affairs of CSR Promotion Dept. are transferred to Human Resources & General Affairs Dept. under Administrative Division.
 - 8) Business Sustainability Planning Dept. is dissolved.
