

Changes to Organizational Structure; Assignment of Directors and Corporate Officers; Other Personnel Changes

Osaka, Japan – December 14, 2016 – TOYO TIRE & RUBBER CO., LTD. (President: Takashi Shimizu), announces the following changes to the organizational structure, the assignment of Directors and Corporate Officers, and other personnel changes.

- 1. Organizational Structural Changes:
 - 1) The Company is changing its Group Headquarters structure from the existing division by business category to one organized by operational function, as follows:
 - The planning and management functions are integrated into Corporate Headquarters. The following units will be re-established within Corporate Headquarters: Corporate Planning Division; Product Planning Division; Administrative Division; Corporate Purchasing Division and SCM Division.
 - b. The Quality Assurance Division and Compliance & Legal Division are re-established under Quality Assurance & Compliance Headquarters.
 - c. The Production Engineering Division and Environment & Safety Enhancement Division are re-established under the Environment, Safety & Production Engineering Headquarters.
 - d. The Production Division is re-established under Production Headquarters.
 - e. Central Research Center, R&D Division No.1 and R&D Division No.2 are re-established under R&D Headquarters.
 - f. Original Equipment Sales Division, Domestic Sales Division and Overseas Sales Division are re-established under Sales Headquarters.
 - 2) The North American Business Development Dept. is established to further strengthen the North American business.
 - 3) Global Project Development Dept. is established to expand business globally.
